#### **GENERAL PURPOSE**

Crew leaders shall work together to assist the Director with coordinating personal for projects; help with paperwork, such as work orders, confined space entries and trenching permits. # ESSENTIAL DUTIES AND RESPONSIBILITIES

Leading crews on assigned projects to see that projects are completed and performed in a professional, cost effective and timely manner

Accurately filling out work orders for assigned projects accounting for personnel, equipment and materials used on a daily basis.

Overseeing all aspects of assigned projects including but not limited to project preplanning, crew safety, traffic control, vehicle and equipment maintenance, and quality control

Working with the Director and other Crew Leader to schedule vacations and other forms of leave to avoid overlap whenever possible

Operates all Public Works Department heavy and light equipment when needed including but not limited to; graders, excavators, loaders, trash compactors, tractor trailers, sweepers, back-hoes, dump trucks, snowplows, vactor trucks, sidewalk plows and skidsteers

Performs all other related duties as required or assigned including those outlined in the position description for a Public Works HEO

#### Necessary Knowledge, Skills and Abilities:

- (A) Proven ability to safely and properly operate and perform regular daily maintenance on all heavy and light equipment used by the public works department.
- (B) General skills in the operation of listed tools and special equipment used by public works.
- (C) Ability and willingness to effectively lead, coach and train any and all of the outside crew members of the Public Works Department.
- (D) Ability to understand and follow oral or written instructions; Ability to communicate effectively verbally and in writing; Ability to observe proper safety precautions; Ability to establish effective working relationships with other employees
- (E) Ability to perform as the competent person on an excavation site in accordance with the Department of Labor and Industries standards

- (F) Extensive knowledge of the standard municipal winter maintenance techniques, materials and protocols
- (G) Must possess or have the ability to acquire extensive knowledge of all provisions of the bargaining agreement between AFSCME Council 93 and the City of Brewer

# TOOLS AND SPECIAL EQUIPMENT

Curbing machine, crack sealer, air hammers and drills, compactors, concrete mixer and other masonry tools, compressor, generators, line painter, powered hand tools and common hand tools, surveyor's level, pipe laser, and builder's laser

# PHYSICAL DEMANDS
