#### Program Snapshot

**Maine's venture capital fund investing exclusively in Maine companies who demonstrate a potential for high growth and public benefit.**

SEGF is a professionally-managed venture capital fund that invests in Maine companies demonstrating the potential for high growth and public benefit. The Fund has been actively investing in Maine companies since 1997, after its creation by an act of the Maine Legislature in 1995 to provide Maine companies and entrepreneurs access to patient sources of venture capital. The fund has received \$13 million in capital contributions from the State of Maine and operates as a revolving, "evergreen" fund. The Fund's mission is to provide resources to attract, support, and help develop eligible small businesses with the potential for substantial growth and success that will contribute to the prosperity of Maine.

The SEGF is looking for companies that display the following characteristics: experienced management team, unique product in a strong market, compelling value proposition, scalable business model and clear and realistic exit strategy. Other requirements for possible investment in a company are:

- Employ 50 or fewer people or have gross sales of \$5,000,000 or less within the past 12 months;
- Provide evidence of the need for financial assistance to realize its projected growth and achievement of public benefit; and
- Demonstrate a co-investment in an amount at least equal to the investment amount sought from the Fund.
