A. Minutes of March 6, 2018 Regular Meeting (Councilor Uhlenhake)

ACTION: Councilor Uhlenhake moved that the minutes be accepted and placed on file. The motion was seconded and passed with unanimous vote.

B. Awards, Petitions and Public Comments

Public Comments

ACTION: Councilor Ferris requested that in light of the current events in our society, especially the Parkland shootings, he would like the Council to talk about school safety and what steps the Council can take to help, as long as it is permitted by state law, federal law and City of Brewer charter. Some ideas that he would like the Council to discuss and maybe take effect by City Ordinance are; minimum age to buy firearms, banning the sale of assault weapons in our City, firm up back ground checks, and don't allow gun shows in our City. He would like to act on the momentum created and show the students and City that the Council is listening. Councilor Ferris said he, along with Mayor Goss and City Manager Stephen Bost met with Brewer Public Safety Director and Deputy Police Chief and feels that his opinion is completely opposite of the Police Department on this issue. Councilor Ferris feels that ideas the police department have are more focused on the individual or the mental health of these individuals and although he has no issue working on those issues too, he would like to focus more on the weapons themselves. City Solicitor Jody Dearborn, although passing the baton tonight to the new City Solicitor Jonathan Pottle, recommends that the Council gets some insight from Solicitor Pottle, after he has had time to speak with the police department, and hold a workshop in the near future so the Council can have this discussion. Councilor Uhlenhake supports looking into this process further and requests that the Mayor look into it with City Staff. Mayor Goss relayed that he had already started that process by working with City Staff to start development of a comprehensive position paper that will give the Council a starting point to generate further discussion and develop a position for the Council. Councilor Uhlenhake clarified that the position statement that the city departments are putting together is just a draft, not a final opinion, it will be a starting point, Mayor Goss agreed. Councilor Ferris requested that a member of the Council be included in the drafting of the paper. Councilor O'Connell volunteered to help draft the paper. Councilor Ferris reminded everyone that this all may be for not if we do not get a recommendation from the City Solicitor that this is an area the Council can legislate. Mayor Goss assured everyone that the committee will definitely take recommendations from the City Solicitor first and foremost. Councilor O'Connell stated that he was at an organized march the past couple of days and he relayed that we should be very proud of these "kids" that they are very mature, very capable and we should support them and be extremely proud of them. Mayor Goss agreed and said that he and Councilor Uhlenhake were at the school during the "walk out" when the Brewer kids did not walk-out; they met in the gym, a safer venue, and he gives them a great deal of credit for that; and stated that the kids appreciated the Council's appearance and he hopes that this paper will let the kids know that the Council means what they say. Mayor Goss thanked Councilor Ferris for raising this whole topic up and thinks that the Council now has a better direction on where they are going and how they are going to get there for the May meeting.

Mayor Goss presented a recent copy of the Maine Town & City magazine where there were two articles on City Staff, Linda Johns, City Planner and Dave Cote, Public Works Director. Mayor Goss requested that the articles be recorded in the minutes so that they go on public record and people see what a great team Brewer has on a daily basis. Councilor Ferris made a motion to accept the articles and place them on file with the City Clerk. The motion was seconded and passed by unanimous vote. (See attached articles)

Chairman Goss asked Brewer's Economic Development Director, D'arcy Main-Boyington to address the Council on this application. D'arcy stated that the purpose of this public hearing was part of an application to the State of Maine CDBG program where the City of Brewer is applying for a grant and if we are successful the City will receive a portion of the Federal funds allocated to the state which cities and towns compete for. If the City of Brewer is successful and receives those funds, we would then grant these funds out to Waltzing Matilda USA, a leather working manufacturer, so they can move their manufacturing facility from New York to here in Brewer. D'arcy explained that as a stipulation of this grant, in order to qualify, the applicant must create new jobs, and in this case, two new jobs, that will go to employees in the low to moderate income households. If the applicant does not do this, if they do not "meet benefit" the funds can be requested to go back to the state and eventually the federal government. D'arcy assured the Council that the steps are in place to make sure that this does not happen that the applicant plans on hiring from the Career Center, which can pre-qualify any employees, making sure that they meet the requirements, the City also has the process structured so that the applicant will not actually receive the funds until both hires that meet the requirement have been made.

Economic Development Director, D'arcy Main-Boyington introduced Mike Balitsaris, the owner of Waltzing Matilda USA who explained what his company is, how it came to be and his goals; he also had some of his products with him to show the Council.

Mayor Goss stated that he sees this company starting small and exploding and he hopes that the explosion happens here in Brewer because it will be huge. Councilor O'Connell read a letter that Mike Allen, President of Winterport Boot Company had submitted for the public hearing (see attached). Mayor Goss pointed out that the Brewer Business Alliance and CES, Inc. also submitted letters of support for Waltzing Matilda's application and he would like to have those entered into the minutes. Councilor Ferris made a motion that the letters of support be accepted and placed on file. The motion was seconded and passed with unanimous vote.

The Brewer Water Department will hold a public hearing, pursuant to 35-A MRSA § 6104, on March 27th, 2018 at 6:00 p.m. in the City Council Chambers at City Hall in Brewer. The purpose of the hearing is to:

- 1.Review a proposed 10.0% increase in the current water rates for all metered services of the Brewer Water Department and
- 2.give customers the opportunity to testify, pose questions, and make comments regarding the proposed rate increase.

The proposed increase in water rates would provide an increase of \$150,337 in the annual revenues of the Department.

Customers have the right to an open and fair hearing, and to further hearings before the Maine Public Utilities Commission. Customers may petition the Commission to investigate the proposed rate change; signatures on customer petitions filed pursuant to 35-A MRSA § 6104(7) are invalid unless accompanied by the printed names and addresses of the signers. Pursuant to 35-A MRSA § 6104(7), the petition must include the signatures of at least 537 customers of the Brewer Water Department and be submitted within 30 days of the public hearing. Brewer Water Department will, upon request, provide customers with petition forms that include spaces for signatures and the printed names and addresses of the signers. Customers may also request assistance from the Public Advocate, State House Station 112, Augusta, ME 04333, or telephone (207) 287-2445, or www.maine.gov/mpuc.

Materials supporting the rate increase are available at the Department's office, 223 Greenpoint Road, Brewer, Monday – Friday (excluding holidays) between 8:30 a.m. and 4:30 p.m. Customers have the right and are encouraged to review these materials and to request information relating to current and proposed rates.

Chairman Goss asked Brewer Water Superintendent Rodney Butler to address the Council. Superintendent Butler explained that the last water rate increase for Brewer residents was in 2005 and the department works hard to keep the water rates steady but with the current infrastructure aging and needing repair, the department is proposing a 10% increase to address those needs.

Chairman Goss asked if there were any public comments in regard to this application. There were none.

Chairman Goss closed the public hearing.

WHEREAS, the 2018 filing proposes to keep public and private fire protection rates unchanged as these rates still slightly exceed recommended thresholds established by the MPUC; and

WHEREAS, in particular, when public fire protection revenue is proposed to exceed 30% of gross revenue for a water system, the MPUC requires the municipality formally accept the waiver of this recommended limit; and

WHEREAS, the Brewer Water Department's long term goal is to bring public and private fire protection rates in line with MPUC recommendations over time as the economics of the water system allow;

NOW THEREFORE BE IT ORDERED, that the Brewer City Council reaffirms the Brewer Water Department's existing authorization for its public fire protection allocation to exceed the 30% limit established by the MPUC.

Statement of Fact

The proposed rate increase filed with the Maine Public Utilities Commission on February 20, 2018 includes proposed revenue from public fire protection (hydrants) that, at 32%, exceeds the 30% limit set in MPUC rules. This order reaffirms the 2008 waiver of this limit to avoid having to increase metered water rates more than currently proposed.

TITLE

AMEND CHAPTER 24, ENTITLED "LAND USE CODE" OF THE CITY OF BREWER CHARTER, CODES AND ORDINANCES, ARTICLE 4, PERFORMANCE STANDARDS, TO ADD SECTION 441 MOBILE FOOD BUSINESSES, AND ARTICLE 14, DEFINITIONS.

BE IT ORDAINED by the City of Brewer in City Council assembled that Chapter 24, of the Charter, Codes and Ordinances of the City of Brewer, entitled "Land Use Code" shall be amended by adding the following subsection to Article 4 and adding the following definitions to Article 14:

ARTICLE 4 PERFORMANCE STANDARDS

441. MOBILE FOOD BUSINESSES

Mobile food businesses shall include mobile food trailers, mobile food trucks, mobile ice cream vendors, and mobile food pushcarts. See Article 14 of this Land Use Code for definitions.

411.1 All entities desiring to operate a mobile food business within the City shall meet the following requirements:

1. Obtain a license from the City of Brewer. Said license shall include the type of mobile food business, number of mobile units, location and hours of operation. Such license shall be issued by the City Clerk upon certification of the Health Officer, Code Enforcement

Officer, Police Chief, and the Fire Chief, or their designees. The fee for said license shall be in accordance with the City of Brewer Schedule of Fees.

- 2. <u>Must meet local inspections.</u>
- 3. All food truck owners/drivers must consent to and pass a background check conducted by the Brewer Police Department and demonstrate proof of vehicle insurance. General liability insurance is required when operating on City property.
- 4. <u>Must have all necessary licenses and permits from the State of Maine.</u>
- 5. <u>Must meet NFPA adopted standards.</u>
- 6. <u>Must supply a written traffic management plan approved by the Brewer Police Chief or his/her designee. This does not apply to mobile ice cream vendors and mobile food pushcarts.</u>
- 7. The business must be used by foot traffic and not as a vehicle drive-thru.
- 8. Must be located in allowed locations. See 441.2 of this Brewer Land Use Code.
- 9. <u>Cannot exceed operating more than 4 hours during any 24 hour period per location without City approval.</u>
- 10. The business infrastructure shall not be permanently affixed to the ground.
- 11. <u>If located on private property, must have written landowner permission.</u>
- 12. Must provide own recycling and trash disposal for the business and patrons.
- 13. Outdoor furniture (such as tables and chairs) is permitted with approval and cannot cause safety hazards. Items must also be removed when business is not in operation. Approval of the outdoor furniture shall be by the Code Office when on private land and by the Parks & Recreation Department when on public land.
- 14. The area around the business must be maintained in a clean and attractive condition.
- 15. All signs shall be physically attached to the unit.
- 16. No horns, amplified systems, or other sound-producing devices or music systems which can be heard outside of the truck may be used. This does not apply to mobile ice cream vendors.
- 17. No alcohol, tobacco, marijuana, or controlled substances may be sold or given.
- 18. No third party advertising may be displayed on any mobile food business.

The above items are required for each license renewal and shall meet the ordinance and/or standards in place at the time of renewal.

441.2 Mobile food businesses are allowed to operate either on public or private land as follows:

- 1. <u>If located on private property, must be located in the Convenience Business (CB), Downtown Development (DD), or the Office Residential (OR) zoning districts. All equipment, tables, chairs, recycling and trash containers must not be located within the public right-of-way of any road or sidewalk.</u>
- 2. Mobile food trucks and mobile food trailers are not allowed to operate in the public right-of-way of any accepted City Street with the exception of that portion of Betton Street which is used as a public parking lot. Mobile Ice Cream vendors are allowed to operate in the public right-of-way of City streets.
- 3. <u>Mobile food businesses are allowed to operate on specific public locations after receiving</u> local license and permit. After receiving a mobile food business license from the City

Clerk's Office, the applicant may proceed to the Brewer Parks and Recreation

Department to request a permit to operate on City property. The Brewer Parks and

Recreation Department shall set specific locations along with allowed dates/times and
maximum number of mobile food businesses for each site. Permits/approvals to operate
on school property shall be obtained through the Brewer School Department.

- 4. <u>Mobile food trucks and mobile food trailers shall not operate:</u>
 - a. At a location where space for pedestrian passage will be reduced to less than four (4) feet;
 - b. At a location which obstructs access to any entrance to any building of a facility used by the public, including but not limited to doors and emergency exits;
 - c. Within ten (10) feet of any handicap access ramp, pedestrian crosswalk or fire hydrant;
 - d. Within two hundred (200) feet walking distance of a business selling food and/or beverages for on-site consumption without the business's written agreement;
 - e. Within any landscaped areas.

ARTICLE 14 DEFINITIONS

Mobile Food Business. A business that serves food or beverages from a self-contained unit either motorized or in a trailer on wheels, and conducts all or part of its operations on premises other than its own and is readily movable, without disassembling, for transport to another location.

Mobile Food Court. A parcel of land where two (2) or more mobile food businesses congregate to offer food or beverages for sale to the public. Any cluster of more than one mobile food business, vending cart and seasonal farm stand, located on the same parcel of land shall be considered a mobile food court.

Mobile Food Trailer. A mobile food business that serves food or beverages from a non-motorized vehicle that is normally pulled behind a motorized vehicle. The term "mobile food trailer" shall not include vending carts, mobile food trucks, or mobile ice cream vendors.

Mobile Food Truck. A mobile food business that serves food or beverages from an enclosed self-contained motorized vehicle. The term "mobile food truck" shall not include vending carts, mobile food trailers, or mobile ice cream vendors.

Mobile Ice Cream Vendors. Individuals selling pre-packaged novelty ice cream from a non-stationary vehicle or mobile pushcart. Open food handling such as, but not limited to, flavored grinding ice and pretzels are not allowed.

Mobile Food Pushcart. A portable vending device, pushcart, or other wheeled vehicle or devise which may be moved without the assistance of a motor and which is not required to be licensed and registered by the Department of Transportation, used for the displaying, storing, or transporting of food offered for sale by a vendor. Said cart may be up to four (4) feet in width,

six (6) feet in length, excluding auxiliary items such as handles or fenders, or otherwise the cart shall not occupy space greater than a total of twenty-four (24) square feet.

Statement of Fact

These ordinance amendments are proposed in order to allow mobile food businesses to operate within the City of Brewer under specific regulations.

The Planning Board held a public hearing on March 5, 2018 and unanimously made the recommendation to adopt these amendments.
