WHEREAS, the conveyance of the right of way to the City of Brewer included a "Temporary Turnaround", or cul-de-sac, that was intended to expire and revert to the grantor if and when Atlantic Avenue was extended; and

WHEREAS, the cul-de-sac was never constructed, and Atlantic Avenue has not been extended; and

WHEREAS, the owner of the property encumbered by the paper cul-de-sac (Fransway Realty, LLC) has requested that the City declare that the area within the cul-de-sac has been abandoned, which allows the construction of a new parking lot adjacent to Atlantic Avenue for the purpose of accommodating an expansion of the UPS operation; and

WHEREAS, the Brewer Planning Board approved a site plan application by Fransway Realty, LLC at its August 2018 meeting for the construction of the new parking lot; and

WHEREAS, Fransway Realty, LLC has proposed to design, construct and deed to the City of Brewer, a Permanent Easement providing a suitable "hammerhead" type turnaround at the end of Atlantic Avenue in substitution for the abandoned cul-de-sac; and

WHEREAS, the City Engineer and the Public Works Director have reviewed the layout and location of the proposed hammerhead turnaround and deemed it sufficient for the purpose of turning a city plow truck.

NOW, THEREFORE, BE IT ORDERED, that the Brewer City Council hereby declares that pursuant to 23 M.R.S. § 3028(2), the area encompassed by a 60' radius at the end of Atlantic Avenue as defined in the Deed from Epstein and Kurson to the City of Brewer dated 12-30-1965 and recorded at the Penobscot County Registry of Deeds in Book 2034, Pages 379-380 has been abandoned pursuant to common law due to lack of public use for a period in excess for 20 years; and

BE IT FURTHER ORDERED, that the City Manager, or his designee, is hereby authorized to sign any and all documents necessary to carry out this Order.

Statement of Fact

This Order declares that an unbuilt paper cul-de-sac at the end of Atlantic Avenue (see attached pdf) has been abandoned by law. This paper cul-de-sac has been deemed by City staff to be of no value and is an obstruction to the development of the adjacent property. As substitution for the cul-de-sac, the owner of the adjacent property (Fransway Realty, LLC) has proposed to construct a suitable turnaround for plow trucks or other vehicles.

WHEREAS, the Brewer Fire Department will be receiving one cardiac monitor (estimated cost \$35,000) and five AEDs (estimated cost \$2,200 each) to replace its outdated cardiac monitor and two existing AEDs; and

WHEREAS, the three additional AEDs will allow the City to equip Fire trucks that don't currently carry this important lifesaving equipment; and

WHEREAS, the grant requires a 10% local cost match, which will be covered by the trade in value of the retired equipment.

NOW, THEREFORE, BE IT ORDERED, that the City of Brewer, by vote of its City Council, herewith accepts these grant funds and the equipment purchased with them; and

BE IT FURTHER ORDERED, that the City Council hereby declares the Fire Department's existing cardiac monitor and two AEDs surplus and authorizes the City Manager or his designee to trade in the equipment to meet the City's local match requirement.

WHEREAS, since it opened in 2013, the City's Riverwalk Trail has been a source of pride and enjoyment for the citizens of Brewer and the region as well as a focal point and generator of economic activity on the waterfront; and

WHEREAS, construction of Phase II of the Riverwalk Trail will be completed this fall and will draw even more people to the City's waterfront and downtown area; and

WHEREAS, maintaining the safety and accessibility of the trail is integral to Brewer citizens' enjoyment of the facility and to maximizing the economic development opportunities that can be realized from this investment; and

WHEREAS, to preserve a safe and accessible trail, the Brewer Police Department has recommended the purchase of two pieces of equipment: a permanent radar sign for South Main Street to help slow traffic on this heavily traveled road and a UTV (utility terrain vehicle) to patrol and respond to incidents on the trail; and

WHEREAS, costs for the solar powered radar sign are estimated at approximately \$7,500; and

WHEREAS, three quotes were obtained and costs to purchase and equip with emergency gear the Kawasaki UTV KAF 820 KJF as well as a shed to house the vehicle are estimated at \$22,500; and

WHEREAS, costs to prepare the location for the shed, including sitework, a concrete slab and electrical are estimated at \$10,000; and

WHEREAS, expenses associated with the waterfront trail are an eligible, state-approved use of TIF funds:

NOW, THEREFORE, BE IT ORDERED, that the City of Brewer, by vote of its City Council, herewith authorizes the appropriation and expenditure of up to \$40,000 in tax increment financing special revenue funds from CIP account 0150121-551102 (Waterfront Trail) to purchase and install the safety equipment specified above.

Statement of Fact

With Phase II of the Riverwalk Trail about to open and draw even more people to the City's waterfront area, this order authorizes the use of \$40,000 in TIF funds to purchase equipment to preserve and enhance trail safety and accessibility. It authorizes the installation of a radar sign on South Main Street to slow traffic and the purchase of an emergency equipped Kawasaki Mule side by side and a shed in which to house it.
