WHEREAS, orders passed by the Brewer City Council do not become effective until five days after approval unless such orders contain emergency preambles; and

WHEREAS, it is imperative that this order become effectively immediately upon its passage to allow this purchase to commence without delay; and

WHEREAS, these facts create an emergency within the meaning of the Charter, Code and Ordinances of the City of Brewer and require that the following order become effective immediately upon its approval to protect the public health, common welfare and safety of the citizens of Brewer;

WHEREAS, the Brewer Fire Department has taken its primary engine, Engine 301, out of service due to enhanced frame corrosion and is currently using the spare, Engine 302, a 1990 Pierce Arrow pumper, as its primary response vehicle; and

WHEREAS, at 27 years of service, Engine 302 had been slated for replacement and is experiencing increased mechanical issues due its advanced age; and

WHEREAS, to ensure adequate emergency response capabilities, the Fire Department recommends the City immediately purchase a replacement Class A pumper; and

WHEREAS, the Fire Department has solicited and evaluated quotes for such engines available for immediate delivery; and

WHEREAS, the Fire Department recommends the City purchase a "demo" 2016 Pierce Saber pumper, which was the lowest cost of the used-only-for-demonstration-purposes models that fit the needs of the City and is available for immediate delivery;

NOW, THEREFORE, BE IT ORDERED, that the Brewer City Council hereby authorizes the purchase of the 2016 Pierce Saber pumper demo engine for \$450,000 delivered; and

BE IT FURTHER ORDERED, that this purchase shall be charged to account 0510132-551234 (Fire Engine 302 Replacement) and paid for with current cash flow and be added to the anticipated spring 2018 bond issue for financing; and

BE IT FURTHER ORDERED, that the Brewer City Council herewith exercises its authority under Chapter 36, Section 404 of the City's Purchasing Ordinance for the purchase of this equipment.
