Amend Article IX, Recall, of the City of Brewer City Charter as follows:

## ARTICLE IX. RECALL

Any member of the City Council <u>or the School Committee</u> may be recalled and removed therefrom by the electors of the City as herein provided.

## SECTION 1. PROCEDURE FOR INITIATING RECALL PETITION.

Any 50 registered voters of the City of Brewer may originate a petition putting into operation the recall process by signing such petition at the office of the City Clerk. Whenever requested by 50 such voters, the City Clerk shall prepare the proper recall petition and upon its being signed by said 50 voters, the City Clerk shall file the petition and shall, during office hours for 30 days thereafter, keep the same open for signatures by registered voters of the City, and no such petition shall be signed or presented for signatures at any place other than the Clerk's office. At the expiration of said 30 days, the City Clerk shall declare the petition closed and shall, at the first regular meeting of the City council thereafter present to that body, the petition with verification of the number of valid signatures there attached. If the number of valid signatures at the latest regular city election, the City Council shall immediately take the necessary steps to submit to the voters of the city and the recall petition.

## SECTION 2. FORM OF BALLOT IN RECALL ELECTION.

The form of the ballot at the recall election shall be as follows:

"Shall City Council member (name of person proposed for recall) be recalled?"

"Shall School Committee member (name of person proposed for recall) be recalled?"

Immediately below such question shall appear in the following order the words "Yes" and "No" and to the right of each word a square an oval within which the voter may cast his <u>or her</u> vote.

## **SECTION 3. VOTE REQUIRED.**

In order for a Council member or School Committee member to be recalled, at least 30% of the total number of qualified electors registered to vote after the close of polls on the date the recall election is held must have voted and a simple majority of said 30% must have voted "Yes". In the event less than 30% of said electors vote or a simple majority of said majority do not vote "Yes", the recall fails.

## SECTION 4. ELECTION AFTER RECALL.

A Council member <u>or School Committee member</u> recalled shall serve until his <u>or her</u> successor is duly elected and sworn. If one or more Council members <u>or School Committee members</u> are recalled, the City Council shall declare a vacancy and shall set a time for the holding of a special election not less than 30 days nor more than 60 days after the recall election.

## **SUMMARY**

The purpose of the proposed Amendments to the City of Brewer Charter is to provide the same recall provisions for School Committee members as are outlined in the City Charter for City Council members.

Amend Article IX, Recall, of the City of Brewer City Charter as follows:

## ARTICLE IX. RECALL

Any member of the City Council <u>or the School Committee</u> may be recalled and removed therefrom by the electors of the City as herein provided.

## SECTION 1. PROCEDURE FOR INITIATING RECALL PETITION.

Any 50 registered voters of the City of Brewer may originate a petition putting into operation the recall process by signing such petition at the office of the City Clerk. Whenever requested by 50 such voters, the City Clerk shall prepare the proper recall petition and upon its being signed by said 50 voters, the City Clerk shall file the petition and shall, during office hours for 30 days thereafter, keep the same open for signatures by registered voters of the City, and no such petition shall be signed or presented for signatures at any place other than the Clerk's office. At the expiration of said 30 days, the City Clerk shall declare the petition closed and shall, at the first regular meeting of the City council thereafter present to that body, the petition with verification of the number of valid signatures there attached. If the number of valid signatures attached to said petition shall amount to at least 500 signatures of qualified electors registered to vote at the latest regular city election, the City Council shall immediately take the necessary steps to submit to the voters of the city and the recall petition.

## SECTION 2. FORM OF BALLOT IN RECALL ELECTION.

The form of the ballot at the recall election shall be as follows:

"Shall City Council member (name of person proposed for recall) be recalled?" and/or

## "Shall School Committee member (name of person proposed for recall) be recalled?"

Immediately below such question shall appear in the following order the words "Yes" and "No" and to the right of each word a square an oval within which the voter may cast his <u>or her</u> vote.

## **SECTION 3. VOTE REQUIRED.**

In order for a Council member or School Committee member to be recalled, at least 30% of the total number of qualified electors registered to vote after the close of polls on the date the recall election is held must have voted and a simple majority of said 30% must have voted "Yes". In the event less than 30% of said electors vote or a simple majority of said majority do not vote "Yes", the recall fails.

## SECTION 4. ELECTION AFTER RECALL.

A Council member <u>or School Committee member</u> recalled shall serve until his <u>or her</u> successor is duly elected and sworn. If one or more Council members <u>or School Committee members</u> are recalled, the City Council shall declare a vacancy and shall set a time for the holding of a special election not less than 30 days nor more than 60 days after the recall election.

## SUMMARY

WHEREAS, Emera Maine has filed an application for a property tax abatement with the Brewer City Council; and

WHEREAS, the application for the abatement is based upon the taxpayer providing the assessor with erroneous information that was relied upon for the 2012-2013 (FY13) tax assessment; and

WHEREAS, Title 36 M.R.S.A § 841 allows the taxpayer to apply to the municipal officers for an abatement based upon an error after one (1) year but within three (3) years from the date of the assessment; and

WHEREAS, the City Council, as the municipal officers, are required to hold a hearing and make a decision, including reasons, within sixty (60) days after the application for the abatement was mailed; and

WHEREAS, a hearing was held on August 11, 2015, at which time the applicant presented testimony, as well as the City of Brewer's Assessor;

NOW, THEREFORE, based upon the evidence presented, it is hereby ordered that the appeal submitted by Emera Maine is (granted) (denied) for the following reasons:

The application for abatement fails to meet the burden of proof that the assessment for FY13 was manifestly wrong for one or more of the following reasons:

1. The judgment of the Assessor was irrational or so unreasonable in light of the circumstances that the property is substantially overvalued and an injustice results:

2. There was unjust discrimination, or

3. The assessment was fraudulent, dishonest or illegal

- 4. The application for abatement fails to meet the criteria of Title 36 MSRA section 841 which requires that an illegality, error, or irregularity in assessment occurred. The assessment was correct based on the information available to the assessor at the time commitment. A reporting error was discovered after commitment was finalized, however this does not mean the assessor erred in creating the assessment and therefore is not grounds for abatement under section 841.
- 5. This determination is supported in part by the Maine supreme court decision Golstein v Town of Georgetown which states in part:

"... mistakes will be made, particularly in situations where the mistake in valuation would not be obvious from observation. For that reason, section 841 provides a mechanism for correction of errors in valuation. This process recognizes that, in such "error in valuation" circumstances, the taxpayer may be in a better position to have the essential information to point out the error. Accordingly, the burden is placed upon the taxpayer to justify the abatement. However, in "error in valuation" circumstances, the time for objection is limited to 185 days so that the Town's financial commitments, beyond individual fiscal years, are not unduly disrupted by stale claims for abatement."

AND FURTHER, BE IT ORDERED, that Emera Maine is entitled to an abatement of \_\_\_\_\_, if the application has been granted; and

FURTHER, BE IT ORDERED, that if the abatement is denied, Emera Maine has the right to appeal to the appropriate forum within sixty (60) days of the decision pursuant to Title 36 M.R.S.A. § 843 and 844.

ACTION: Councilor Goss moved that the order have passage. The motion was seconded.

Councilor Uhlenhake asked Mr. Silk about State Statute 553 since he had referred to it during the public hearing discussion and it was not contained in the packet of information that he had provided for council.

Mr. Silk said the statute says it means that real estate has to be taxed in the place where it is to the owner or person in possession. The same real estate cannot be taxed twice in the same municipality.

Councilor Uhlenhake asked if the council members could go into executive session with the City's solicitor to get some legal clarification.

Councilor Uhlenhake moved that the three council members, who would be voting on this order and the City solicitor go into executive session.

The motion was passed by a 3 to 0 vote, Councilors Ferris and O'Connell abstaining.

Mayor Vachon said the executive session include City Council members Goss, Uhlenhake and Mayor Vachon.

Mayor Vachon said the regular meeting would resume after the executive session and take up the rest of the items on the agenda.

The meeting was called back to order at 7:08. The City Clerk called the roll and all members of the council were present.

Councilor Uhlenhake moved that the order be amended by striking out the word "granted" in the sixth paragraph of the order. The motion was seconded and passed. The motion to amend was passed by a 3 to 0 vote, Councilors Ferris and O'Connell abstaining.

Councilor Uhlenhake moved that the order be further amended by inserting the reasons for denial in the last paragraph of the order as shown above. The motion was seconded and passed. The motion to further amend the order was passed by a 3 to 0 vote, Councilors Ferris and O'Connell abstaining.

Councilor Uhlenhake moved that the order, as twice amended, have passage. The motion was seconded and the order, as twice amended, was passed by a 3 to 0 vote, Councilors Ferris and O'Connell abstaining.
