A. Minutes of December 8, 2015 Regular Meeting and December 28, 2015 Special Meeting.

ACTION: Councilor Ferris moved that the minutes be accepted and placed on file. The motion was seconded and passed by unanimous vote.

B. Awards, Petitions and Public Comments.

1. Presentation by PERC on Waste Management.

Robert Knudsen, Vice President of operations for the USA Energy, the majority owner of Penobscot Energy Recovery Co. asks the City Council to hold off making a decision as to where to send its trash after 2018 and consider a term contract with PERC for 2018. He said he understood that there were those who predict that PERC will not be viable after the contract with Emera expires. He said they would be viable. He invited the Council members to attend one of the workshops that are being held around the area on this subject.

City of Brewer Finance Director Karen Fussell, who is also a Municipal Review Board member, did a presentation at the December 8, 2015 Council meeting recommending the City of Brewer partner with Fiberight when the contract with PERC ends. She said that the Municipal Review Committee still believes that PERC will not be financially viable and it would be difficult for PERC to remain open at current standards without the Emera subsidies.

2. PUBLIC COMMENTS.

Richard Kelly, 49 Alan-A-Dale Road, Brewer, Maine said he is a 25 year employee of PERC and that 7 out of 75 employees live in Brewer. He said he is an engineer there. He would like the City Council to hold off on making a decision on this issue tonight.

WHEREAS, to stop any further deterioration of the frame structure as well as to protect the longevity and integrity of these apparatuses it has become necessary to have these truck's frames serviced by Copia Specialty Contractors Inc. located in Bangor, Maine; and

WHEREAS, by having the frame structures serviced it would extend the life of these apparatuses to meet the projected life span of 25 years from date of purchase; and

WHEREAS, Copia Specialty Contractors has quoted a cost of \$6,775.00 to complete the work on Ladder Truck #305 and \$7,950.00 to complete the work to Engine Pumper #301 for a total expense for services performed not to exceed \$15,000.00;

NOW, THEREFORE, BE IT ORDERED, that the City of Brewer by vote of its City Council, does hereby authorize the City Manager or his designee to execute a purchase order to procure this service; and

FURTHER ORDERED, that the costs of these frame improvements be charged to 0510132-551224 (Fire Unit 305 Refurbishing) and 0510132-551223 (Fire Unit 301 Refurbishing); and

FURTHER ORDERED, that the City Council authorizes the appropriation and expenditure of \$15,000 in CIP Unallocated fund balance for these repairs;

FURTHER ORDERED, that the City Council of the City of Brewer herewith exercises its authority under Section 404 of the City's Purchasing Ordinance, Chapter 36 of the Charter, Codes and Ordinances of the City of Brewer in the purchase of contractor services for this project.

NOW THEREFORE BE IT ORDERED, that the Brewer City Council hereby authorizes the City Manager and/or his designee to sign a Corporate Card Service Agreement with the Bank of America and related documents necessary to implement Purchasing Cards and other purchasing services for the City of Brewer.

STATEMENT OF FACT

This order authorizes the City to implement a purchasing card program through the Bank of America. There is no cost to the City for the program.

("MRC"), organized as a Maine nonprofit corporation and acting as a regional association pursuant to Title 13-B and Title 38 of the Maine Revised Statutes, as amended (and specifically Section 1304-B(5-A) of Title 38) for the purposes of managing and facilitating solid waste disposal; and

BE IT RESOLVED, that the Brewer City Council hereby adopts, ratifies and confirms the Restated Articles of Incorporation and the Restated Bylaws of the MRC in substantially the form on file with the City Clerk and attached to this resolve; and

BE IT RESOLVED, that the City Manager, or his designee, hereby is authorized to execute and deliver a Municipal Joinder Agreement with the MRC in substantially the form on file with the City Clerk and attached to this Resolution (the "Municipal Joinder Agreement") pursuant to which the City of Brewer will be a Joining Member of the MRC (as defined therein) and deliver its municipal solid waste for disposal to a waste management facility being developed by Fiberight, LLC and/or its affiliates (collectively, "Fiberight") in Hampden, Maine, or other waste disposal facility; and

BE IT RESOLVED, that the Brewer City Council hereby authorizes the MRC to take certain actions on behalf of the City of Brewer as set forth in the Municipal Joinder Agreement;

NOW, THEREFORE, BE IT RESOLVED, by the Brewer City Council that the City Manager, or his designee, is authorized as a representative of the City of Brewer to execute and deliver the Municipal Joinder Agreement on behalf of the City of Brewer and to execute and deliver on behalf of the City of Brewer in conjunction therewith such other documents and to take such further actions as they may deem necessary or appropriate in order to effect the transactions contemplated by the Municipal Joinder Agreement.

STATEMENT OF FACT

This resolution authorizes the continuation of the City's Municipal Review Committee (MRC) membership, acceptance of the MRC's restated bylaws and articles of incorporation and directs the City Manager to sign a Municipal Joinder Agreement with the MRC for waste services starting in 2018. Adopting this resolution will provide 15 years of waste processing and disposal for the City and its businesses once the City's contract for disposal at PERC expires on March 31, 2018. It provides for a starting tip fee of \$70 per ton, an annual CPI escalator, a minimum of a \$5 per ton reduction in the tip fee in the first three years, and provision to share in profits of facility above a certain level.

ACTION: Councilor O'Connell moved that the resolve be adopted. The motion was seconded.

ARTICLE 2 ADMINISTRATION AND ENFORCEMENT

205. APPLICANT RESPONSIBILITY

205.4 CERTIFICATE OF OCCUPANCY

1. No land shall be occupied or used and no building hereafter erected, altered or extended, shall be used or changed in use until a Certificate of Occupancy shall have been issued by the Code Enforcement Officer, stating that the building or proposed use thereof complies with the provisions of this Land Use Code and any other codes and ordinances of the City of Brewer. All buildings which have been vacant for one (1) year or more shall also require a new Certificate of Occupancy issued by the Code Enforcement Officer, stating that the building or proposed use thereof complies with the provisions of this Land Use Code and any other codes and ordinances of the City of Brewer.

STATEMENT OF FACT

This ordinance change is necessary to require buildings that have been vacant for more than a year to obtain a new Certificate of Occupancy before being reoccupied. This is important on foreclosed homes that have been vacant for a long period of time to make sure the buildings are up to date on the standards for life safety.

ACTION: Councilor Vachon moved that one certified copy of the proposed ordinance

amendment be filed with the City Clerk for posting. The motion was seconded

and passed by unanimous vote.
