The City Clerk swore in Benjamin Umel as a member of the Brewer Superintending School Committee, for a three year term and Ashley Blanchard for a one year term to fill a vacancy and Jacob Cote as the Student Representative Member of the School Committee. Lester Young was sworn in as High School District Trustee for a five year term..

I am thankful for:

- Family and their support/God and country and friends
- For the people who got out and voted Tuesday because it is their right and duty (an example is of the elderly lady who with two canes walked from her car did not want any help to vote and a police officer who had come with his spouse to vote together but got called away before they got to vote. I admire their resolve.
- Thankful to work with these four other individuals (Council members). We all add a different character to this group to make it an effective and efficient City Council
- So very thankful to work with the employees of the great city. Every minute of every day the operation of Brewer is a total team effort from the top to the bottom
- Communication is key to the success of any organization with all of our employees. It is a great thing!

- Two new crosswalks with lighting at St. Theresa's Church/Maple Street and So. Main Street
- Complete resurfacing of Wilson Street from Parkway So. to Joshua Chamberlain Bridge
- Constructed new parking and resurfaced Penobscot Street
- New LED lighting for Dirigo Drive
- Constructed new public parking lot adjacent to CHOM project
- CHOM project completed, tenants in
- Somerset Place, old middle school project, completed and tenants in
- Completed Eastern Avenue culvert replacement
- Finished Doherty Complex project
- Repaved Woodridge Road, Sylvan Road, Green Point Road, Summit Street and Woodlawn Cemetery
- Demolished and removed four dilapidated unsafe structures
- Public Wi-Fi installed on Brewer Waterfront Trail
- Web GIS now on line, over 95 active forms and apps, 24, 000 documents/photos on line

- Multiple grants awarded to Police and Fire Departments for everything from pagers and water back pumps to MEMA use of force simulator/training
- Some new businesses include Masimo's Breads, Black Canvas Brewing, Harvest Moon Deli, Logical Sip Café, Wild Bill's Leather and Mason's Brewing
- Extension of the Waterfront Trail from Joshua Chamberlain Bridge to the Penobscot Bridge has been approved with a tunnel so that people do not have to cross Wilson Street to get to other parts of the trail

WHEREAS, an individual's character is measured through the management of one's ego, envy, timidity, ambition and/or craving for personal publicity;

NOW, THEREFORE, BE IT RESOLVED, that the true Brewer public servant:

- will not act out of spite, bias, or favoritism;
- contributes to a climate of mutual trust and respect;
- does not succumb to peer or political pressure;
- refuses to let official action be influenced by personal relationships, including those arising from past or prospective employment;
- has the courage of his or her convictions;
- does not try to shift blame to others;
- never forgets that he or she is working for the people <u>all</u> the people;

NOW, THEREFORE BE IT RESOLVED, That the members of the Brewer City Council formally adopt and actively pursue the Ethical Principles for Public Servants provided by the "Council for Excellence in Government," 1992;

- 4. Clearly Define Roles and Relationships
- 5. Establish and Abide by a Council-Staff Partnership
- 6. Make a Systematic Evaluation of Policy Implementation
- 7. Allocate Council Time and Energy Appropriately
- 8. Set Clear Rules and Procedures for Council Meetings
- 9. Get a Valid Assessment of the Public's Concerns and An Evaluation of the Council's Performance
- 10. Practice Continuous Personal Learning and Development As a Leader

He has continued that Trustees Tradition of being a sound, thoughtful individual that wants what is best for our students, stakeholders and citizens of the Brewer Community. He has taught us a lot and we want to thank him for all this and wish him well in his future plans.
