Presentation: Pedestrian Safety Action Plan, Patrick D. Adams, Maine DOT

WHEREAS, six out of ten Americans are considered overweight or obese; and

WHEREAS, studies have shown that most adults strongly prefer outdoor exercise to indoor exercise; and

WHEREAS, health clubs provide a high-quality experience for adults who want to improve their health and wellness, but are not an option for every adult due to financial constraints; and

WHEREAS, outdoor fitness areas provided by community parks remove the financial barrier to regular exercise; and

WHEREAS, the City of Brewer wishes to install fitness equipment at the end of the Riverwalk at Veteran's Park to attract new users to our waterfront, including the Center Street business area, and encourage adults to exercise regularly and improve their fitness; and

WHEREAS, the Economic Development Department has researched options to incorporate fitness equipment into the City's Riverwalk and found that the GameTime Thrive 900 is specifically made to appeal to adults and provide all of the necessary elements of a well-rounded fitness program, including aerobic fitness, muscle development, core strength, and balance and flexibility; and

WHEREAS, the Thrive 900 combines multiple types of fitness exercises into a single, compact unit, making it a great option for locations with limited space, like Veteran's Park; and

WHEREAS, the Thrive 900 will work as a catalyst to encourage non-exercising adults to be more active, and provides a stage to perform a variety of exercises for multiple fitness levels at each station so it can be used by people of all abilities and fitness levels; and

WHEREAS, Machias Savings Bank has agreed to donate \$25,000 towards the purchase of this specific Thrive 900 system; and

WHEREAS, the City has tax increment financing (TIF) funds available to cover the remaining estimated \$43,000 cost to purchase and install the equipment.

NOW, THEREFORE, BE IT ORDERED, that the City of Brewer, by vote of its Council herewith authorizes the appropriation and expenditure of up to \$43,000 in tax increment financing (TIF)

funds from the Riverwalk Fitness Park expense account (0510121-551102-57023) to supplement the \$25,000 private donation toward this project; and

WHEREAS, in 1999 the City entered into a Cooperative Ambulance Agreement with Meridian Mobile Health, LLC (dba Capital Ambulance and now named Northern Light Medical Transport (NLMT)) to provide ambulance services to the City of Brewer based out of the Public Safety Building; and

WHEREAS, the City and NLMT have renewed and extended the Agreement multiple times, with the current Agreement set to expire on March 31, 2021; and

WHEREAS, the City and NLMT have negotiated mutually agreeable terms to continue the fruitful partnership for another three years, through March 31, 2024;

NOW, THEREFORE, BE IT ORDERED, that the City Council hereby authorizes the City Manager or his designee to finalize and sign an Agreement with Northern Light Medical Transport to provide ambulance services through March 31, 2024 under terms substantially the same as included in the attached draft Agreement.

Statement of Fact: The City's contract for ambulance services with Northern Light Medical Transport (NLMT) expires on March 31. This order authorizes the City to sign a new contract that would continue these services through March 31, 2024. NLMT pays the City approximately \$186,700 per year for the right to serve Brewer and base an ambulance at the Public Safety Building.

TITLE: ORDER, AUTHORIZE REALLOCATION OF FUNDS TO COVER INSURANCE DEDUCTIBLE EXPENSE.

WHEREAS, on July 3, 2020, the communications tower at the Public Safety Building was struck by lightning; and

WHEREAS, the charge caused significant damage to the communications tower and radio shack, and allowed an electrical surge to travel across lines and inside the building causing damage to a phone circuit board in the IT room; and

WHEREAS, there was also significant damage to the police department repeater, the automated gate, the overhead pages/alert system in the fire station; and

WHEREAS, this also caused electrical damage to the backup generator and other sensitive electronic equipment; and

WHEREAS, the City incurred \$45,891.98 in costs to repair the damage, all of which has been reimbursed by the City's insurer except the City's \$10,000 deductible.

NOW THEREFORE BE IT ORDERED, that the Brewer City Council hereby authorizes the reallocation of \$10,000 from the City's Deductible Expense account (0116200-501290) to the Police Building Maintenance and Repair account (0115820-504000) (\$8,000) and to the Fire Building Maintenance and Repair account (0115911-504000) (\$2,000) to cover the deductible expense.

Statement of Fact: This order authorizes the reallocation of \$10,000 from the insurance deductible expense account to the Police and Fire building maintenance accounts to cover the deductible cost associated with the City's \$45,891.98 insurance claim resulting from the July 3, 2020 lightning strike damage to the Public Safety communications tower and associated equipment.

TITLE: ORDER AMEND CHAPTER 9, ENTITLED "FIRE PREVENTION" OF THE CITY OF BREWER CHARTER, CODES AND ORDINANCES.

BE IT ORDAINED, by the City of Brewer in City Council assembled that Chapter 9, of the Charter, Codes and Ordinances of the City of Brewer, entitled "Fire Prevention" shall be amended by adding a new Article as follows:

CHAPTER 9 – FIRE PREVENTION

Article 13. COST RECOVERY FOR SERVICES

Section 1301. Purpose. The City is engaged in providing fire suppression, fire and public safety, and other emergency response services, and in consideration of services rendered, desires to establish the restitution policy for fire and public safety services as set forth in this Article.

Section 1302. Authority. This Article is adopted pursuant to and consistent with the Municipal Home Rule Powers as provided for in Article VIII, Part 2, Section 1, of the Constitution of the State of Maine, and Title 30-A M.R.S.A. § 3001.

Section 1303. Applicability

Section 1303.1. The provisions of this Article shall govern all emergency and non-emergency incident scenes to which the Brewer Fire and/or Police Departments are dispatched or requested by the Penobscot County Communication Center, written mutual aid agreement, or any State or local agency including, but not limited to: control or confine hazardous materials; extinguish fire; respond to motor vehicle/traffic incident; remove or mitigate safety hazards; or provide overall scene safety.

Section 1303.2. This Article shall be applicable to all individuals or entities who receive emergency or non-emergency services provided by the Brewer Fire and/or Police Departments, as specified in this Article.

Section 1304. Responsibility. Parties to any incident to which this Article is applicable (i.e., "Responsible Party") shall provide the Brewer Public Safety Director and/or Incident Commander with sufficient personal and insurance information, including, but not limited to policy numbers and contact

information for their underwriters and agents, to enable the City of Brewer to file claims with the Responsible Party's insurance carrier(s) or a third-party agency to recover the costs incurred during the incident.

Section 1305. Establishment of Fees. The Brewer Public Safety Director shall establish and update as needed a schedule of fees for the delivery of emergency and non-emergency services by the Brewer Fire and Police Departments for personnel, supplies, and equipment to the scene of emergency and non-emergency incidents. The schedule of fees shall be based on actual costs of the services and that which is usual, customary, and reasonable, which may include any services, personnel, supplies, and equipment and may also include costs incurred by other City departments participating in the incident response.

Section 1306. Restitution and Billing Procedure.

Section 1306.1. The City may seek restitution for costs of City services by filing claims with the Responsible Party's insurance company. The City is authorized to enter into a cost recovery agreement with a third-party billing company for the billing and collection of fees for Fire Department services through the filing of insurance claims. All such claims shall be submitted in the name of the City. The City shall only seek restitution for services from insured individuals or companies.

Section 1306.2. The Finance Director is authorized to institute legal action to collect insurance claims that remain outstanding for more than 60 days. Any legal and late fees associated with the attempt to collect outstanding payments incurred by the City shall be added to and in addition to the original claim. The Finance Director is authorized to write off claims, when a claim is not paid with a valid reason (e.g., insured but not at fault, not covered) or if all attempts to contact the insurance company fail by any common method available.

Section 1307. Administration and Enforcement. It shall be the duty of any third-party billing company with a valid cost recovery agreement with the City to effectively pursue the requirements of this Article for payment of services rendered by the City as specifically outlined herein.

Section 1309. Insurance Requirements. The third-party billing company shall at all times have valid General Liability insurance policy, a Cyber Liability policy, an Errors and Omissions Policy, and the City shall be named as an additional insured on such policies.

Section 1310. Severability. Sections of this Article shall be deemed severable. In the event any section, clause, or provision of this Article is declared invalid, the same shall not affect the validity of this Article as a whole or any part thereof other than the part so declared to be invalid.

Section 1311. Conflict with Other Sections. This Article shall not in any way impair or remove the necessity of compliance with any other applicable rule, ordinance, regulation, bylaw, permit, or provision of law.

Statement of Fact: This ordinance amendment will allow the City to seek reimbursement from insurance companies for costs incurred responding to emergency incidents. The City intends to use a third-party provider to pursue these claims.
