Bids must be delivered to the office of the Public Works Purchaser 221 Green Point Rd., Brewer, Maine 04412 before the date and time appointed.

We reserve the right to accept all, part, or decline the whole bid. Bids will not receive consideration unless submitted strictly in accordance with the following instructions. Bids shall be in individual sealed envelopes, one envelope for each vehicle bid. **Mark individual Envelopes Plainly – “BID FOR 2 yd. DUMP TRUCK/SNOW PLOW”.**

1. Bids will be to furnish the City of Brewer with bids for one (1) 2 yd. four-wheel drive Diesel Utility Dump Truck/Snow Plow with a Poly Caster Sander according to the following and/or attached specifications.
2. Bids shall be exclusive of all Federal and State sales tax, shall be inclusive of all charges and fees, shall indicate list, discount (where applicable), allowances and net prices, F.O.B. Brewer Public Works Department, Brewer, Maine.
3. Bidder shall submit with proposals the latest printed specifications and illustrations as advertised by the manufacturer of all equipment quoted, and shall include a warranty on basic unit and attached equipment, and date of delivery.
4. Basic unit and equipment or attachments shall be for the latest models available (manufactured 2021 or 2022), fully tested, serviced, ready to operate and complete in accordance with the specifications, and satisfactory to the City Department Head and the City Manager.
5. All things not expressly mentioned in these specifications but involved in carrying out their intent are required by these specifications, and the Vendor shall perform the same as though they were specifically mentioned, described and delineated.
6. Bidder may be required to demonstrate (within the State of Maine) to the satisfaction of the City of Brewer, within 10 days following the opening of bids, that the equipment proposed will both meet the specifications and do the functions required.

7. In making awards, consideration will be given to price, quality, delivery time, parts availability and service offered. **Included in the bid price, Bidder receiving award shall supply on delivery, 1 hard or paper copy of operating manual. They must also deliver 2 copies of the parts manual and 1 copy of shop service manual. Manuals can be hard copy or an electronic equivalent, either DVD/CD, or free-web-based site. A retainer in the amount of 5% of the contract value will be held pending receipt of these manuals.**
8. Bidder shall address each individual item on the attached specification sheets, indicating how it differs. Any item omitted may result in the bid being rejected entirely. Vendor must complete a bid form for each pickup they are bidding on.
9. By submission of this proposal or contract, the prospective participant certifies that neither it nor its principals are presently debarred, suspended, proposed for debarment, declared ineligible, or voluntarily excluded from doing business with any Federal department or agency. Furthermore, the prospective participant, if selected, agrees to ensure that any subcontractors it uses also meet this standard.
10. The City of Brewer is an Equal Opportunity Employer and Service Provider. The prospective participant, if selected, agrees that it shall not discriminate against any employee or applicant for employment because of age, sex, race, creed, color, national origin, ancestry, marital status, or sexual orientation.
11. The City of Brewer, acting through its City Manager, reserves the right to accept or reject any or all bids in whole or in part. The City of Brewer, acting through its City Manager, reserves to itself the exclusive right to accept high bids when the City Manager, in his sole discretion, believes it would be in the best interest of the City of Brewer. In making such a decision, the City Manager may consider, but not be limited to, any of the following factors: quality, quantity, specifications, availability, service, location of bidder and reputation of bidder.
