

Section §15688; and

Explanation: The school administrative unit's contribution to the total cost of funding public education from pre-kindergarten to grade 12 as described in the Essential Programs and Services Funding Act is the amount of money determined by state law to be the minimum amount that a municipality must raise in order to receive the full amount of state dollars.

BE IT FURTHER RESOLVED, that **\$150,825** be raised and appropriated for the annual payments on debt service previously approved by the municipality's legislative body for non-state-funded school construction projects, or non-state-funded portions of school construction projects in addition to the funds appropriated as the local share of the municipality's contribution to the total cost of funding public education from pre-kindergarten to grade 12; and

Explanation: The additional local funds are those locally raised funds over and above the school administrative unit's local contribution to the total cost of funding public education from prekindergarten to grade 12 as described in the Essential Programs and Services Funding Act and local amounts raised for the annual payment on non-state funded debt service that will help achieve the (municipality/district) budget for educational programs.

WHEREAS, the submission was placed on the Maine DWSRF Backup Project List; and

WHEREAS, the Maine Drinking Water Program (MDWP) has approved 6% principal forgiveness to projects on the Backup Project List to be given as a grant to fund the initial project design; and

WHEREAS, the MDWP has awarded the Brewer Water Department \$149,000 principal forgiveness to cover the cost of design construction and specifications; and

WHEREAS, acceptance of this money is not tied to future use of DWSRF funding or other requirements.

WHEREAS, the Municipal Pool currently has a water line that is cracked and needs to be replaced; and

WHEREAS, the pool flow rate should be increased to meet today's industry standards and this can be achieved by installing a new pump, filter and larger water lines to the pump; and

WHEREAS, contractor Mike's Pool Service, who has serviced the pool in the past, has provided the City with a quote of \$65,000 to purchase and install the necessary equipment; and

WHEREAS, the City has unspent capital improvement bond proceeds that can be applied to cover most of this cost.

NOW, THEREFORE, BE IT ORDERED, that the Brewer City Council authorizes the appropriation and expenditure of up to \$65,000 from CIP account 0510124-551432 (Pool Rehabilitation), for the purpose of contracting with Mike's Pool Service of Brewer, Maine to complete the pool pump and filter upgrade described above; and

BE IT FURTHER ORDERED, that the City Council hereby authorizes the reallocation of \$52,733 of Highland Community Affordable Housing TIF bond proceeds from 0510120-551121 (Parking Lot-former State and Middle Schools) to 0510124-551432 (Pool Rehabilitation) to be added to the \$11,469 in AHTIF bond proceeds in the account already; and

BE IT FURTHER ORDERED, that the Council hereby authorizes the appropriation and expenditure of an additional \$798 in CIP Unallocated Fund Balance from 0510124-551432 (Pool Rehabilitation) to bring the total available in that account to \$65,000 to fully cover the cost of the pool pump project; and

BE IT FURTHER ORDERED, that the City Council of the City of Brewer herewith exercises its authority under Section 404 of the City's Purchasing Ordinance, Chapter 36 of the Charter, Codes and Ordinances of the City of Brewer in the purchase of equipment and contractor services for this project.

The Brewer Environmental Services Director shall establish and update as needed a schedule of fees for all hauled wastewater services provided by the Brewer Environmental Services Department. The schedule of fees shall be based on actual costs of the services and that which is usual, customary, and reasonable, which may include any Brewer City Ordinances contained in Chapter 31.

Statement of Fact: The cost of operating the Brewer Water Treatment Plant has increased. Chemical costs and lab costs have all risen dramatically in the past year. This ordinance amendment will give the Environmental Services Department the ability to adjust fees more regularly to stay up to date with the cost of treatment.
