Mayor Phanthay asked if there had been any written comments received from the public. The city clerk said there were none.

Mayor Phanthay invited the City of Brewer Code Enforcement Officer Kristie Rines to speak. The Code Enforcement Officer said that 361 North Main Street was a City-owned, tax acquired property that was in very poor condition. The Code Enforcement Officer said that several areas of the foundation that were failing, the foundation was crumbling and falling in, and that the house had additions that were sagging and falling off. The Code Enforcement Officer said the house was dilapidated and had been vacant for years.

Councilor Ferris asked why the City had acquired the property. City of Brewer Assistant City Manager James Smith said that the tax lien process was an automatic foreclosure and that the City would only prevent that process in certain circumstances. The Assistant City Manager said that after the foreclosure the City tried to work with the previous owner to address the conditions of the property, but the previous owner was unable to make the closing happen. The Assistant City Manager said that, in April, the previous owner wanted to discuss a repurchase agreement, but it was evident the previous owner didn't have the means or the intentions to address the level of repairs needed to make it a safe and habitable home. The Assistant City Manager said that the building needed to be addressed and that the previous owner was not interested in taking responsibility, and that the hearing could be a step toward demolition of the property if the Council was inclined to go in that direction.

Acting City Solicitor Andrew Hamilton asked if the City sought to exercise the remedies under the dangerous building statute to assure its authority. The Assistant City Manager confirmed that was the City's intention.

Councilor Morin thanked the Assistant City Manager and the Code Enforcement Officer for seeking to address properties like 361 North Main Street, and said that Brewer was better for their efforts. Mayor Phanthay agreed with Councilor Morin.

Mayor Phanthay asked if there were any comments from the public present at the hearing. There were none.

NOW, THEREFORE, BE IT ORDERED, that the City of Brewer, by vote of its City Council herewith agrees to purchase 4 Hardy Street, Brewer, Maine; and

BE IT FURTHER ORDERED, that the Brewer City Council herewith authorizes the appropriation and expenditure of these funds from the Property Acquisition fund 0510101-551100 for the purchase of 4 Hardy Street, Brewer, Maine (Map 28, Lot 176); and

BE IT FURTHER ORDERED, that the City Manager, or his designee, is hereby authorized to take any and all actions and to sign any and all documents necessary to complete this purchase.

Statement of Fact: The City of Brewer will purchase 4 Hardy Street (Map 28, Lot 176) from the heirs of Helen M Cowen for the price of \$300,000 plus closing costs for the purpose of making enhancements to the Riverwalk Trail.

ACTION: Councilor Ferris moved that the order have passage. Councilor Goss seconded the motion. Councilor Ferris said that he would recuse himself from the vote. The motion passed with a 4-0 vote with Councilor Ferris abstaining.

TITLE: ORDER, ENACT AND ADD CHAPTER 51 OF THE CHARTER, CODES AND ORDINANCES OF THE CITY OF BREWER, ENTITLED "CITY OF BREWER MORATORIUM ORDINANCE ON CERTAIN HOUSING REGULATIONS".

WHEREAS, the 130th Legislature of the State of Maine enacted LD 2003, "An Act To Implement the Recommendations of the Commission To Increase Housing Opportunities in Maine by Studying Zoning and Land Use Restrictions" (P.L. 2022, Ch. 672, "LD 2003"); and

WHEREAS, the State-mandated changes to local zoning contained within LD 2003 currently have an implementation date of July 1, 2023; and

WHEREAS, in the current session of the Maine Legislature, there are numerous bills pending that may or may not amend the substantive provisions of LD 2003 and/or postpone its implementation date of July 1, 2023; and

WHEREAS, the Maine Department of Economic and Community Development ("DECD") was tasked with preparing rules for municipalities to assist with understanding LD 2003 and amending local ordinances; and

WHEREAS, DECD has not yet completed said rules, and

WHEREAS, once said rules are completed, the City needs time to review said DECD rules; and

WHEREAS, the City of Brewer desires to revise ordinances to meet the State law and implementing regulations, meet the City of Brewer Comprehensive Plan, and provide the best regulations for the residents of the City of Brewer for orderly and responsible development; and

WHEREAS, the aforedescribed uncertainties and incomplete actions by the State present significant challenges for the City of Brewer to meaningfully prepare, review, and adopt ordinances and/or regulations consistent with LD 2003 and, further, without such enactments by the City of Brewer the current City ordinances are insufficient to prevent serious public harm or overburdening of public facilities given the potential for significantly more dense development in the City of Brewer contemplated by LD 2003; and

WHEREAS, a moratorium is necessary for the City to review its Land Use Code and other applicable Codes and Ordinance to determine the implications of LD 2003 and prepare, review, and adopt ordinance/code provisions to prevent serious public harm or overburdening of public facilities; and

WHEREAS, the process for amending local ordinances takes several months for public hearing, Planning Board review and recommendation, and City Council posting and action; and

WHEREAS, this ordinance amendment procedure cannot be completed prior to the current State implementation date of July 1, 2023 for LD 2003; and

WHEREAS, it is anticipated that said review and development of recommended ordinance changes will take at least one hundred and eighty (180) days from the date the City enacts this Moratorium Ordinance on Certain Housing Regulations.

NOW, THEREFORE, BE IT ENACTED by the City Council of the City of Brewer that the following Chapter 51 entitled "Moratorium Ordinance on Certain Housing Regulations" be, and hereby is, enacted, and, in furtherance thereof, the City Council does hereby declare a moratorium on the acceptance and processing of any applications in the City not currently authorized by existing Ordinances and Codes but have the potential to be authorized through implementation of LD 2003.

This Moratorium Ordinance shall remain in effect for one hundred and eighty (180) days from the date of applicability of this Ordinance, unless extended, repealed, or modified by the City Council, for express purpose of drafting an amendment or amendments to the City's current Land Use Code and other applicable Codes and Ordinances to adequately address the requirements of LD 2003, as may be amended.

BE IT FURTHER ENACTED, that notwithstanding the provisions of 1 M.R.S.A. § 302 or any other law to the contrary, this Ordinance, when enacted, shall govern any zoning regulations for which an application for a building permit, Certificate of Occupancy, site plan, subdivision, or any other required approval has not been submitted to and granted final approval by the Code Enforcement Officer, Planning Board, or other City officials or boards prior to the applicability date of this Ordinance.

BE IT FURTHER ENACTED, that during the time this Moratorium Ordinance is in effect, no officer, official, employee, office, administrative board or agency of the City shall accept, process, approve deny, or in any other way act upon any application for a license, building permit, Certificate of Occupancy, special exception review, site plan review, subdivision review, and/or any other permits or licenses related to the regulation created by LD 2003 unless existing City ordinances and regulations authorize such activity(ies).

BE IT FURTHER ENACTED, that those provisions of the City's current Land Use Code and other applicable Codes and Ordinances that are inconsistent or conflicting with the provisions of this Ordinance, are hereby repealed to the extent that they are applicable for the duration of the moratorium hereby ordained and as it may be extended as permitted by law, but not otherwise.

BE IT FURTHER ENACTED, that if an entity is in violation of this Ordinance, each day of any continuing violation shall constitute a separate violation of this Ordinance, and the City shall be entitled to all rights available to it in law and equity, including, but not limited to, fines and penalties, injunctive relief, and its reasonable attorney's fees and costs in prosecuting any such violations; and

BE IT FURTHER ENACTED, that should any section or provision of this Ordinance be declared by any court of competent jurisdiction to be invalid, such a declaration shall not invalidate any other section or provision.

Statement of Fact: This Moratorium Ordinance is to prevent certain housing and development activities that are contemplated from legislation of LD 2003 that are not currently authorized by existing City ordinances and regulations for a period of one hundred eighty (180) days from the date of enactment of this Moratorium Ordinance.

ACTION: Councilor Goss moved that the amendment be tabled. Councilor Daniels seconded the motion. The motion passed with a unanimous vote. ***

BE IT ORDAINED, by the Brewer City Council that Chapter 24, of the Charter, Codes and

Ordinances of the City of Brewer, entitled "Land Use Code", Article 4, "Performance Standards", Section 442.7.17 shall be amended as follows:

442.7.17 Reactivate a discontinued solar energy system – An owner or operator may submit a written request to the Brewer Planning Board to reactive reactivate a solar energy system that has been discontinued or abandoned due to extenuating circumstances. The Brewer Planning Board shall be responsible for the review and approval or denial of any written request to reactivate a solar energy system, subject to applicable review criteria for a new permit to operate the system. Unless the Board approves a request to reactivate the system, the solar energy system shall be considered abandoned.

Statement of Fact: This ordinance amendment corrects a typographical error in Amendment 2020-C004 as a ministerial matter. This ordinance amendment was posted by the city clerk on June 1, 2023, and is eligible to be enacted at the regular meeting on June 13, 2023.

ACTION: Councilor Morin moved that the amendment be enacted. Councilor Daniels seconded the motion. The motion passed with a unanimous vote.

TITLE: ORDER, AMEND CHAPTER 24 OF THE CHARTER, CODES AND ORDINANCES OF THE CITY OF BREWER, ENTITLED "LAND USE CODE", ARTICLE 4, "PERFORMANCE STANDARDS", SECTIONS 426 AND 436, ARTICLE 6, "SITE PLAN REVIEW", SECTIONS 605.1, 606, AND 610, AND ARTICLE 14, "DEFINITIONS".

BE IT ORDAINED, by the Brewer City Council that Chapter 24, of the Charter, Codes and Ordinances of the City of Brewer, entitled "Land Use Code", shall be amended by revising the following subsections to, Article 4, Article 6, and Article 14:

ARTICLE 4 PERFORMANCE STANDARDS

426 PLANTING

Planting set-back for all trees and shrubs with a potential height of over three (3) feet shall be governed by the following:

426.1 There shall be a minimum set-back of seven (7) feet from the street right-of-way line, on all straight-of-ways.

- **426.2** At street intersections where a radius of curvature is shown on the plan or deed, the minimum set-back line shall be determined by locating the edge of the right-of-way trees, plants or shrubs-seven (7) feet behind said right-of-way line and/or twenty feet (20') from the edge of the travel way until the point of tangency, whichever is greater.
- **426.3** At street intersections where there is no <u>known</u> radius or <u>of</u> curvature allowed, the minimum set-back line shall be <u>twenty feet (20') from the edge of travel way until the point of tangency</u> determined by locating a line parallel to and fifteen (15) feet wider than the existing street lines concerned. These fifteen (15) foot set back lines shall then become the minimum set back line for planting.



- 426.4 Landscaping and plantings shall also adhere to the minimum requirement for clear space around hydrants as included in Chapter 40 (Water Department), Section 303 of the City of Brewer Charter, Codes and Ordinances.
- 436 YARDS AND SETBACKS
- 436.7 <u>FENCES</u>

There shall be a seven foot (7') front yard setback for fences when along a public road, private road, or common driveway. At intersections where a radius of curvature is shown on the plan or deed, the minimum set-back line shall be seven (7) feet behind said right-of-way line and/or twenty feet (20') from the edge of the travel way until the point of tangency, whichever is greater. At street intersections where there is no known radius of curvature, the minimum set-back line shall be twenty feet (20') from the edge of travel way until the point of tangency.



<u>Fences may be placed directly on side and rear property lines.</u> Consideration should be made for access to maintain the fence.

<u>Fences shall also adhere to the minimum requirement for clear space around hydrants as included in</u> <u>Chapter 40 (Water Department), Section 303 of the City of Brewer Charter, Codes and Ordinances.</u>

ARTICLE 6 SITE PLAN REVIEW

605.1 EXPIRATION OF PLANNING BOARD APPROVAL (#2)

The ability and procedure of a major site plan to be approved and constructed in phases shall be determined on a case-by-case basis by the Planning Board. If permitted, details of such phasing shall be outlined on the site plan and written Planning Board Order. Previously approved site plans may be eligible for phasing if brought before the Planning Board for an amended site plan review within eighteen months of approval.

Site plan approval granted by the Planning Board shall expire if the work or use involved is not commenced within one year of the date which the approval is granted, or if the work is not substantially completed within eighteen months of the site plan approval date. For projects approved for completion in phases, site plan approval shall expire if the work does not meet the phasing conditions approved for the project.

Expiration of the applicable dates prior to commencement or substantial completion shall void the site plan approval unless the Code Enforcement Officer has granted an extension for a period

not to exceed ninety days based on the Code Enforcement Officer's written finding of a reasonable cause. If additional extensions are required, the Planning Board may grant such additional extensions based on a written finding of reasonable cause.

Requests for the Planning Board to grant an extension shall include a letter stating the reason for the extension request, proposed extension date, and the non-refundable fee as set forth in the then current City Council adopted fee schedule, payable to the City of Brewer. Three (3) copies of the above information and the check shall be submitted to the Planning Department four weeks prior to the Planning Board meeting.

606 REQUIRED INFORMATION (#2)

Application for the establishment of uses <u>and/or site improvements</u> requiring site plan review shall be accompanied by plans (one inch equals twenty feet is preferred) drawn to scale, and accompanying written materials bound either in a punch and bind or 3-ring binder. <u>Site plans shall</u> <u>be based on field measurements and current on-site data prepared, signed, and stamped by a State of</u> <u>Maine licensed professional land surveyor, engineer, or landscape architect.</u> For purposes of site plan review, the "site" consists of the entire parcel of land and not just the portion developed. The required submission containing at a minimum the following information:

610 SITE PLAN AMENDMENTS

Minor revisions to an approved site plan may be permitted by the City Planner, subject to the following conditions:

610.1 A narrative and revised plan(s) showing the revision is submitted (in three copies) to the Planning Department along with the non-refundable fee as set forth in the then current City Council adopted fee schedule, payable to the City of Brewer.

ARTICLE 14 DEFINITIONS

Structure: Anything constructed, built or erected, the use of which requires a temporary or permanent location on the ground, or attached to something temporarily or permanently located on the ground. This term shall not include <u>fences, retaining walls</u>, sidewalks, walkways, driveways, out-door parking lots and their attendant paving.

Statement of Fact: These ordinance amendments are proposed in order to clarify items, update site plan procedures, and better address setbacks for landscaping and fences. The Planning Board held a public hearing on June 5, 2023 and unanimously made the recommendation to adopt these amendments to Chapter 24 Land Use Code as written.

ACTION: Councilor Ferris moved that the amendment be enacted. Councilor Goss seconded the motion. The motion passed with a unanimous vote. Mayor Phanthay announced that the amendment was certified and would be filed with the city clerk for posting.
