# To Whom It May Concern:

Please quote prices on the following articles F.O.B. Brewer Public Works Department, Brewer, Maine. Bids will close at 2:00 P.M. on Thursday, April 11th. Bids must be delivered to the <u>Public Works Purchaser, 221 Green Point Rd, Brewer, Maine 04412</u> before the date and time appointed, bids received after the specified time and date will be rejected. The bid opening will be held at the Public Works facility immediately following the closing.

The City of Brewer reserves the right to accept or reject all or part of any bids received. Bids will not receive consideration unless submitted strictly in accordance with the following instructions. Mark Envelopes Plainly – "BID FOR GRADER"

- 1. Bids will be to furnish one (1) Grader according to the following and/or attached specifications.
- 2. Bids shall be exclusive of all Federal and State sales tax and shall indicate list, discount (where applicable), allowances and net prices, F.O.B. Brewer Public Works Department, Brewer, Maine.
- 3. Bidder shall submit with proposals the latest printed specifications and illustrations as advertised by the manufacturer of all equipment quoted. Bid shall include details of manufacturer's warranty on basic unit and attached equipment plus date of delivery.
- 4. Basic unit and equipment or attachments shall be for the latest models available, fully tested, serviced, ready to operate and complete in accordance with the specifications, and satisfactory to the Public Works Director and the City Manager. The Grader must meet all Federal, State, and EPA Tier 4 regulatory standards for the construction industry.
- 5. All things not expressly mentioned in these specifications but involved in carrying out their intent are required by these specifications, and the Vendor shall perform the same as though they were specifically mentioned, described and delineated.

- 6. Bidder may be required to demonstrate (within the State of Maine) to the satisfaction of the City of Brewer, within 10 days following the opening of bids, that the equipment proposed will both meet the specifications and perform the functions required.
- 7. In making awards, consideration will be given to price, quality, delivery time, parts availability and service offered. Bidder receiving award shall supply on delivery, 2 hard or paper copies of operating, and shop manuals. They must also deliver 2 copies of the parts manual, one hard copy and one electronic equivalent, either DVD/CD, or free access to a web based site. A retainer in the amount of 5% of the contract value will be held pending receipt of these manuals.
- 8. Bidder shall address each individual item on the attached specification sheets, indicating how it differs from the bid specifications. Any item omitted may result in the bid being rejected entirely.
- 9. By submission of this proposal or contract, the prospective participant certifies that neither it nor its principals are presently debarred, suspended, proposed for debarment, declared ineligible, or voluntarily excluded from doing business with any Federal department or agency. Furthermore, the prospective participant, if selected, agrees to ensure that any subcontractors it uses also meet this standard.
- 10. The City of Brewer is an Equal Opportunity Employer and Service Provider. The prospective participant, if selected, agrees that it shall not discriminate against any employee or applicant for employment because of age, sex, race, creed, color, national origin, ancestry, marital status, or sexual orientation.
- 11. The City of Brewer, acting through it's City Manager, reserves the right to accept or reject any or all bids in whole or in part without penalty. The City of Brewer, acting through it's City Manager, reserves to itself the exclusive right to accept high bids when the City Manager, in his sole discretion, believes it would be in the best interest of the City of Brewer, in making such a decision, the City Manager may consider, but not be limited to, any of the following factors: quality, quantity, specifications, availability, service and location of bidder and reputation of bidder.

Grader

#### **GENERAL:**

The equipment shall be a Grader with cutting edges for ice and 1 standard cutting edge, front mounted hydraulic bulldozer blade, and snow plow package with a hydraulic telescoping 12 ft snow wing. All equipment installed and fully functioning

#### **WEIGHT:**

Minimum 38,000 lbs.

#### **ENGINE**:

Minimum of 190HP Diesel or equivalent with automatic reversing fan

#### **POWER TRAIN:**

Differential Lock or Automatic locking differential

# **BRAKES:**

4-wheel braking

### STEERING:

Steering wheel Removable Front Fenders

#### TIRES:

High traction road tires comparable to Bridgeton V-Steel snow wedge

#### **OPERATORS CAB:**

Tall Cab with Heat and AC

Back up camera

Motorola CM 300 45 Watt 2-Way FM Radio with antenna or equal (5bdb minimum antenna)

LED Strobe Warning Lights

#### **HYDRAULIC CONTROLS:**

Manual levers with additional valve splices to accommodate wing with front and rear lift and wing extender or snow package

#### **MOLD BOARD:**

12 foot with float with slip clutch that is at least 20" high

#### **BULLDOZER:**

Straight blade Front mounted hydraulic 2-way Plow 9' feet wide and 35" high

#### **SNOW WING:**

12 ft hydraulic telescopic angled blade full trip with estimated 35 degrees to 50 degrees to body of grader

#### **BLADE:**

Cutting edges for ice along with standard grading

Training by factory representative will be provided for operators and mechanics which to include demonstrations on Graders features
