A. Minutes of the August 13, 2024 Regular Meeting and Minutes of the August 30, 2024 Special Meeting

B. Awards, Petitions and Public Comments

1. Proclamation: Substance-Abuse Recovery Month.

Mayor Morin read the proclamation.

PROCLAMATION SEPTEMBER 2024 SUBSTANCE-ABUSE RECOVERY MONTH

WHEREAS, substance use disorders are a major public health problem that affect people of all ages and backgrounds and create significant medical, societal, and economic costs; and

WHEREAS, in the year 2020, the number of Recovery Community Centers throughout the state of Maine increased from 9 to 13 locations funded by the Maine Recovery Hub, currently there are 19 Recovery Community Centers; and

WHEREAS, in the year 2021, an estimated 631 deaths were caused by drug overdoses in Maine out of a reported 9,538 overdoses, an all-time high for the state, representing a 23% increase over 2020 with 77% of the deaths attributed to the consumption of fentanyl; in 2022 there were 723 deaths with 10,483 total overdoses recorded through emergency departments, EMS, reported community reversals, and law enforcement; the total number of overdoses recorded do not reflect reversed overdoses in which no emergency services were utilized; and

WHEREAS, in 2023 Maine Public Safety (Law Enforcement and EMS) reported 9889 nonfatal overdoses and 1049 fatal overdoses, and in 2024 (January to June) there were 4276 reported nonfatal overdoses and 276 fatal overdoses; and

WHEREAS, during 2022 the State of Maine increased the number of harm reduction supplies administered: the Maine Naloxone Distribution Initiative purchased 42,267 kits (84,534 doses of naloxone), Tier 1 distributors issued 60,015 kits (120,030 doses of naloxone), and the Office of the Maine Attorney General distributed 1,498 kits (2,996 doses of naloxone); and the Maine Syringe Access Program reported distributing 2,368,746 syringes in 2022; and

WHEREAS, the City of Brewer has been a solid partner with local individuals, support groups, and other entities committed to reducing substance abuse in our community and finding programs that prevent, treat and eliminate illicit drug use in all its forms; and

WHEREAS, the City of Brewer believes that substance abuse adversely impacts the quality of life for all and this requires a comprehensive and balanced approach focused on providing access to treatment and recovery services, education, and enforcement; and

WHEREAS, the City of Brewer recognizes that recovery is possible, bringing light where there was darkness, hope where there was despair, connections when there was isolation, accomplishment, and love; recovery restores the sense of health and purpose; and is attainable with the right supports and personal commitment; and

WHEREAS, the City of Brewer encourages all people adversely impacted by substance use disorder to connect with resources and supports to make recovery possible and begin the journey towards a better life; and

WHEREAS, the City of Brewer recognizes and celebrates those in recovery for their journey and accomplishments, who are an example of what is possible.

NOW, THEREFORE, I, JENN M. MORIN, Mayor of the City of Brewer, on behalf of the City Council and citizens of Brewer, do hereby proclaim the month of September 2024 as

WHEREAS, Doyle Field is a centerpiece of the greater Brewer community, hosting numerous events, including Brewer High School athletic contests, and its current sport lighting system is over 35 years old; and

WHEREAS, proposals were solicited, received and evaluated for the removal and replacement of the current lighting system with a new energy efficient Light-Emitting Diode (LED) lighting system; and

WHEREAS, the City of Brewer was awarded a \$232,000 grant from the United States Department of Energy to offset the cost of this purchase, which will improve energy efficiency and reduce light spill; and

WHEREAS, as part of its Fiscal Year 2024 (FY24) Capital Improvement Program (CIP), the City has allocated a portion of its American Rescue Plan Act (ARPA) funds to cover its 50% required cost share of this community project; and

WHEREAS, it was determined that R.L. Todd & Sons, Inc., from Caribou, Maine, has submitted the proposal with the maximum value that would best meet the needs of the City.

NOW, THEREFORE, BE IT ORDERED, that the Brewer City Manager, or his designee, is authorized to sign a contract and purchase order to R.L. Todd & Sons, Inc., in the amount of \$428,019 for the removal of the existing lighting system at Doyle Field in Brewer, Maine, and the purchase and installation of a new lighting system; and

BE IT FURTHER ORDERED, that the Brewer City Council hereby authorizes the expenditure of up to an additional \$65,000 in contingency funding to address unforeseen issues, such as ledge, that may arise during the project; and

BE IT FURTHER ORDERED, that costs associated with this project be charged to the account 0200001-520000-20613 (Doyle Field Light Replacement), funding for which was approved as part of the FY24 CIP.

Statement of Fact: This order provides for the replacement of the Sports Lighting System at Doyle Field as approved in the FY24 CIP budget. Funding for the project comes from a Department of Energy grant and ARPA funds.

TITLE: ORDER, AUTHORIZE CITY MANAGER TO SIGN FREEDOM PARK TRANSFER AGREEMENT.

Filed September 3, 2024 By William Kimball

WHEREAS, Maine Department of Transportation (MDOT) and the Brewer Historical Society entered into a License Agreement on December 6, 2022, of and concerning occupancy and related activities associated with a portion of Freedom Park in the City of Brewer, Maine, a copy of which is attached hereto as Exhibit A (the "License Agreement"); and

WHEREAS, the City of Brewer desires to have the Brewer Historical Society assign the License Agreement to the City of Brewer for the City to assume, the Brewer Historical Society desires to make such assignment, and MDOT has approved such assignment and assumption; and

WHEREAS, the current condition of Freedom Park is in need of enhancements to align with the City's high standards of beauty and cleanliness; and

WHEREAS, assumption of this license agreement provides the City of Brewer with an opportunity to create an attractive point of entry into the City.

NOW, THEREFORE, BE IT ORDERED, that the City of Brewer, by vote of its City Council, herewith authorizes the City Manager, or his designee, to sign a transfer of License Agreement, transferring assignment of Freedom Park in Brewer, Maine, from the Brewer Historical Society to the City of Brewer, and to begin developing a plan for Freedom Park's beautification and maintenance.

Statement of Fact: Maine Department of Transportation and the Brewer Historical Society entered into a license agreement on December 6, 2022 that allowed the Historical Society to occupy and maintain Freedom Park. The Historical Society is no longer able to maintain this parcel of land. Transfer of this license agreement to the City of Brewer will allow the parcel to be maintained by the City.

LICENSE AGREEMENT

This License agreement is made this <u>fit</u> day of <u>Dec</u>, 2022, between the State of Maine, by and through its Department of Transportation ("MaineDOT"), and the Brewer Historical Society ("Licensee").

WHEREAS, the State of Maine, by and through its Department of Transportation, owns property in the City of Brewer, County of Penobscot, State of Maine, as described in a Notice of Layout and Taking and recorded on February 27, 1995 in the Penobscot County Registry of Deeds, Book 5811, Page 156, as shown on a plan entitled "State of Maine Department of Transportation, Right of Way Map, State Highway '43, Brewer, Penobscot County, Federal Aid Project No. BR-038-1 (35), Part 1 BR-BRE-038-1 (35), Part 2" dated June, 1994 and referenced as DOT File No. 0-354, Sheets 7 and 8 recorded in Pian Book 2002, Pages 101 and 102 in said Registry of Deeds (the "MaineDOT Property").

WHEREAS, a portion of the MaineDOT Property was previously the subject of a lease between MaineDOT and the Licensee that expired on June 30, 2022 (the "Lease"). MaineDOT and the Licensee are entering into this License Agreement in lieu of extending the recently expired Lease.

WHEREAS, MaineDOT is willing to enter into this License Agreement with the Licensee to permit the Licensee's continued occupancy of the portion of the MaineDOT Property formerly benefitting from the Lease, subject to the terms and conditions set out herein.

NOW THEREFORE, in consideration of the foregoing, MaineDOT and Licensee hereby agree as follows:

- Maine DOT hereby grants to Licensee a license to enter upon that portion of the MaineDOT Property situated on the northeast quadrant of State Street and North Main Street and depicted as the shaded area on the above-referenced plan attached hereto as Exhibit A for the sole purpose of operating and maintain an existing Civil War memorial (the "Licensed Parcel"), subject to the following terms and conditions:
 - a. Licensee shall be allowed to landscape the Licensed Parcel at its sole expense. Excavations of any kind and the use of pesticides, fertilizers, or herbicides is prohibited on the Licensed Parcel.
 - b. All work and activities performed pursuant to or under authority of this License Agreement shall be done in accordance with all applicable federal, state and local laws and regulations, and other legal requirements.
 - c. Licensee shall provide, at its sole expense, routine maintenance on the Licensed Parcel for the term of this License Agreement. Such maintenance shall include, without limitation, keeping the Licensed Parcel clear of refuse and debris,

performing all appropriate snow and ice removal and treatment activities, and removing all winter sand each spring.

- d. Licensee shall ensure that its use of the Licensed Parcel does not impede the traffic flow or otherwise interfere with traffic safety on State Street or North Main Street.
- The term of this License Agreement shall be ten (10) years, commencing retroactively on July 1, 2022 and ending June 30, 2032. This License Agreement may be renewed for an additional ten (10) year term upon mutual agreement of the parties as to the appropriate terms and conditions of such renewals.
- 3. This License Agreement shall not be assignable or transferable without the prior written consent of MaineDOT, which determination shall be in MaineDOT sole discretion.
- 4. Licensee acknowledges that any and all rights conveyed by this License Agreement may be terminated and this License Agreement revoked by MaineDOT at any time in the event Licensee breaches any of the terms or conditions of this License Agreement or if MaineDOT, in its sole discretion, determines that the Licensed Parcel is needed for transportation purposes. MaineDOT shall give Licensee thirty (30) days written notice of such termination under either circumstance.
- 5. MaineDOT reserves the right to enter upon the Licensed Parcel to perform any required or emergency maintenance as deemed necessary. 
