WHEREAS, on April 11, 2023, the Brewer City Council authorized a Cooperative agreement with the Maine Department of Transportation (MDOT) (Order 2023-A045) in the amount of \$970,000 for the resurfacing of Pierce Road with storm drain improvements and sidewalk construction from Eastern Avenue to Wilson Street on a 70/30 cost sharing basis; and

WHEREAS, also on April 11, 2023, the City Council authorized a Municipal Partnership Initiative (MPI) agreement with MDOT (Order 2023-A044) in the amount of \$180,000 for the resurfacing of Elm Street with sidewalk improvements from South Main Street to the railroad tracks on a 50/50 cost sharing basis; and

WHEREAS, at the October 8, 2024 meeting, the City Council authorized a contract (Order 2024-A184) for the sidewalk and storm drain work on both sections of roadway that must be completed prior to resurfacing; and

WHEREAS, funding for the City's share of costs was approved in the Fiscal Year 2025 (FY25) Capital Improvement Program (CIP); and

WHEREAS, on February 25, 2025, the City received five competitive bids for the resurfacing work from reputable local contractors (see attached bid tabulation sheet).

NOW, THEREFORE, BE IT ORDERED, that the Brewer City Manager, or his designee, is authorized to execute a contract with Vaughn D. Thibodeau II of Bangor, Maine, the low bidder, in an amount not to exceed \$430,000 (bid amount plus approximately 11% for contingencies) for the completion of the Elm Street and Pierce Road resurfacing project; and

BE IT FURTHER ORDERED, that costs associated with the Elm Street MPI project be charged to 0510113-551610-66517, and those with the Pierce Road Cooperative Agreement to 0510113-551379-66516; and

BE IT FURTHER ORDERED, that, in a timely manner, the City Engineer shall invoice MDOT for the State's share of costs for this work, estimated to total \$292,380 for this portion of the project (approximately \$272,595 for the Pierce Road project and \$19,785 for the Elm Street project).

**Statement of Fact:** This order awards the contract for the Elm Street and Pierce Road Resurfacing project to Vaughn D. Thibodeau II General Contractor. This contract will be completed after the previously approved sidewalk and storm drain contract that is expected to be done in spring 2025. The sidewalk and storm drain project has a required completion date of July 1, 2025 and the resurfacing project has a completion date of October 17, 2025.
